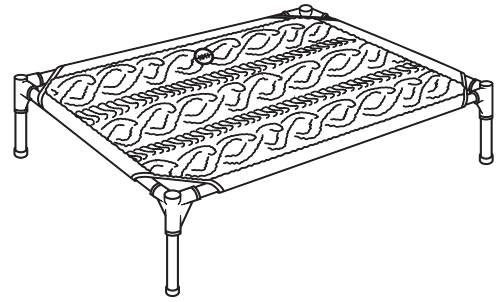

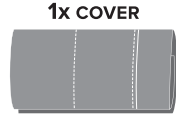

ASSEMBLY INSTRUCTIONS:

BEFORE ASSEMBLY check that you
have received all of the parts needed:

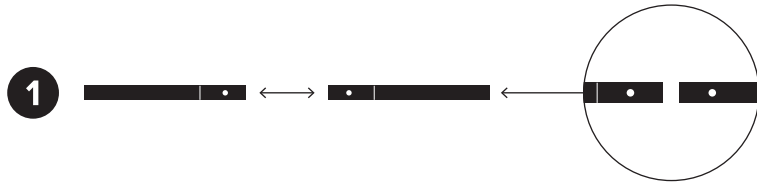


4x ONE DOT
FRAME PIECES

2x LONG
FRAME PIECES

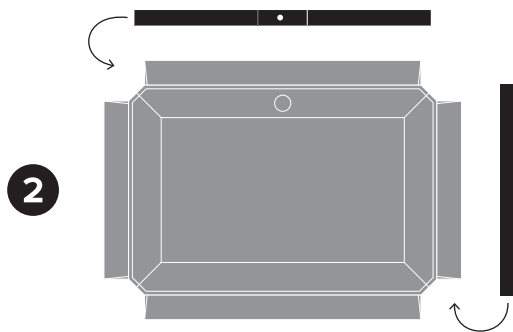


4x CORNER
LEGS



Connect each pair of **ONE DOT FRAME PIECES** together at the connection ends with the dots.

This should result in a total of 2 connected **SIDE** frame pieces.

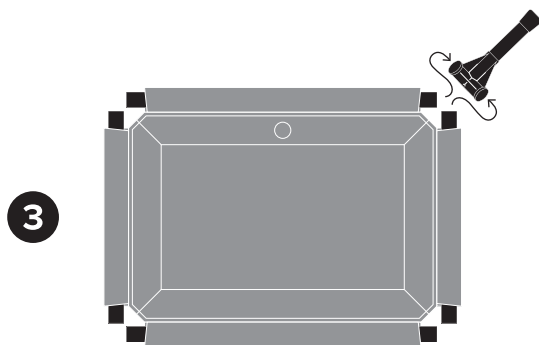


Spread the **COVER** right side down.

Slide each connected **FRAME PIECE** into the corresponding **FABRIC CHANNEL** of the **COVER**.

Connected **ONE DOT** pieces go in the channels on the **LONGER SIDES** of the cover. **LONG FRAME** pieces go in the channels on the **SHORTER ENDS** of the cover.

Repeat for each side of the cover so that every fabric channel has a connected **FRAME PIECE**.



At the corners, connect the **FRAME PIECES** into the two holes of the **CORNER LEG PIECES** with the foot cap facing upwards.

Repeat for the remaining **CORNER LEGS** so that all **FRAME PIECE** ends are secured.

Turn the cot right side up and check that all connections are firmly secured.

CAUTION: Rubber feet are easily removable and have a washer inside. Therefore, pets and small children should be supervised near this product.

PLEASE NOTE: Wash **ONLY** the cover. Remove it the frame entirely before washing. Reassemble following the instructions included.

CARE INSTRUCTIONS:
Machine wash cold gentle cycle.
Line dry or tumble dry low.
Do not bleach.
Do not dry clean or iron.
